Time: Vetting begins Saturday morning for 50 and 25 miles at 6:30 AM. Saturday 15 and 10 milers can vet in at 7:30 Saturday morning. Sunday 50 and 25 milers will vet in Sunday morning at 6:30 AM. Sunday 15 and 10 milers will vet in starting at 7:30AM. All horses MUST be on site by 7:00 the day of the ride

Location : Kedron Valley Stable, South Woodstock, VT

Trail: The trail will be mostly dirt roads with little woodland trails and pavement.

Farrier: Come well shod and carry an EZ boot. Farrier will be on call at the finish of each day.

Food: Light breakfast offerings, on trail snacks and a light lunch will be provided each day.

Rules: This is an ECTRA sanctioned event. All ECTRA rules and regulations apply. Hay, Shavings, Manure and garbage must be picked up. Dogs must be under control at all times.

Facilities and Stabling: LIMITED stabling available on a "first come" basis with priority given to 50 milers at \$25.00/ night. VERY limited parking available for trucks and trailers on site. Please travel with a buddy if possible. Additional parking available at Evergreen Equine Clinic 8.6 miles away. Go 8.4miles south on VT Rt 106 turn onto Rt 44 for .2 miles to Evergreen Equine Clinic.
