**Trail:** The trail will be dirt roads and some class 4 roads

**Farrier:** No farrier, come well shod, and/or bring an e-z boot!

**Food:** Breakfast snacks and coffee before ride. **POTLUCK during and after final vetting.**

**Rules:** **Dogs must be on leash at all times.** NO Dogs preferred. Hay, shavings and manure must be picked up. All ECTRA rules and regulations apply. ECTRA rules require that all riders & drivers wear an ASTM-SEI approved helmet. Rules available at [www.ectra.org](http://www.ectra.org)

**Camping:** There are no stalls. Primitive camping allowed. Please call ahead to reserve a spot!

**Entry Requirements:** Negative coggins test and proof of rabies vaccine (within one year) is required with entry. **Please check your horses temperature before arriving**

**Refunds:** All refunds will be made to any competitor if request is made before the ride date..

**PARKING:** Parking in fields, please follow directions at ride site.

**Directions: (DO NOT FOLLOW GPS) Questions contact secretary (Carrie Maynard)**

From north or south: I-89 to Exit 2 ( Sharon). From north, go right at end of ramp, from south go left. At stop sign, go right on RT 14 north, then take 1st left over the bridge. (about 5 miles from exit)

Bear right at end of bridge, follow River Rd to 2nd left, an underpass across from the Broad Brook Cemetery. You'll now be on Broad Brook Rd. Follow along the brook, bearing right at first split, left at the second, and Balla Machree Farm will be about 2 miles further on. Parking for trailers will be in the field across from the barn.

From west (Rutland): take Route 4 east towards Woodstock. In Woodstock, follow signs for Route 12 towards Barnard. At the Barnard General Store, go right, Silver Lake will be on your left. Follow road along to the first split, bear left up the hill, onto Royalton Turnpike. Follow along for a few miles until the road takes a big bend towards East Barnard. (Landmark for the turn is a big white farm set back from the road; right turn just past that.). In East Barnard, bear left onto Broad Brook Rd, Balla Machree Farm will be on your left, parking for trailers in the field across from the main barn, on your right.
